

Procurement Associations *by Terry Mckee*



One way to increase knowledge about the public procurement process and professional standards is through active membership in professional organizations. Notice that I said “active” membership because simply having your name on a membership roll does not really do much for you. However, being an active member (reading the newsletters, participating in discussion groups, leading sessions, et cetera) goes far in continuing your professional development.

Just as there are professional associations for most careers, procurement has its professional associations also. Each has its own niche and applicability. Below is information about various procurement associations that exist specifically for governmental procurement officials. There are private sector procurement associations (such as ISM) but their applicability public procurement is limited.

NIGP is the international association for public procurement and it has around 2,000 member agencies. These include cities, counties, states, colleges, airports and housing authorities. The membership fee is based upon the size of your entity. NIGP sponsors workshops, e-chat forums, conferences, a specification library and other procurement related services. For additional information go to www.nigp.org.

ETPA The East Tennessee Purchasing Association (ETPA) covers entities from Crossville to Bristol to Chattanooga. It has three general membership meetings a year plus an annual meeting in October. ETPA offers seminars, speakers and a way to ask questions of colleagues via an email chain. The membership fee is \$50.00 per year (for up two members). Go to

MTPPA The Middle Tennessee Public Purchasing Association (MTPPA) covers governmental entities in the center of the State. This group holds monthly lunch meetings at the Nashville Electric Service office. The membership fee is \$20.00 per year. Go to <http://www.mtppa.net/> for additional information.

TAPP The Tennessee Association of Public Purchasing (TAPP) covers governmental entities across the State of Tennessee. Like the other groups mentioned above, TAPP serves to foster education, training and professional development. The membership fee is \$20.00 per year per person. Cookeville HA Resident is Adult HS Valedictorian

Cookeville Housing Authority resident, Crystal Reagan is a true success story. Pictured with her youngest daughter, Carissa, Crystal recently graduated from Cookeville Adult High School as the class valedictorian of 37 graduates.

Crystal is a single mom of 4 children, twins age 13, 9 and 4. She left high school 17 years ago only needing 4 1/2 credits to graduate. Crystal states, "I always felt incomplete. Once I tried to get a job washing dishes but the job required a GED. So I decided I'm going back to school. I wanted to give my children hope that anything is possible and set an example to them as a mom." It took Crystal a year to get her GED.

While in school she found a recurrence of thyroid cancer. She continued on with school even while undergoing cancer treatments although some days she only had strength for one hour of class. Crystal and her children often studied together. Her example to her children has paid off—her twins are on the honor roll and in Beta Club. Crystal has already begun the process of enrolling at the Nashville State Community College branch here in Cookeville to become a Physical Therapy Assistant. Her goals are to get a job and move into her own home.

Crystal openly states, "If it weren't for housing I never would have been able to finish my education and accomplish my goals and move on. To me, that's what it's all about."


Tennessee Governors Conference on Housing October 9-10


